



Strawberry Festival 2018

Dear Art/Craft Vendors,

We would like to invite you to join us for the 16th Annual Strawberry Festival in Slater on Saturday, May 5th, 2018 from 11am to 4pm. The festival is held as a fund-raising event for Foothills Family Resources, a non-profit organization dedicated to serving the residents of Northern Greenville County. The details are as always: public admission to the festival and parking are free. In addition to the usual musical entertainment, food stalls and art/crafts booths, we plan other fun activities, including the ever-popular free children's art space, throughout the day. We have a spacious lawn with some shady areas located on the site of the historic Slater Hall Community Center. The center is located at 5 Whitney St., Slater, SC 29683 (some GPS systems may list Marietta as the city). There is nearby street parking. The ground is uneven in some places.

The following are the terms and conditions for participation:

- The Strawberry Festival is seeking quality self produced arts, crafts, and goods. Industrially produced goods are limited to supplies needed to produce creative works. Direct sellers will be accepted only if they are related to the education or creative art fields. The Art & Craft Vendor Coordinator will determine if the potential vendor meets qualifications.
- If you require electricity, you **MUST** provide your own generator and notify us in good time so that we can locate your booth away from the music.
- You must bring your own table, chairs, canopy and whatever outside comforts you like. Be prepared for any kind of weather. **Rain or shine!**
- Vendors cost for a 12 x 12 space is \$35.00 for the day.
- Vendors keep 100% of the revenue from the sale of their items.
- Set up begins at 8am. No vehicles will be allowed on the grounds after 10:15am. All vehicles must be off the grounds by 10:45am.
- **Cut-off for registration is April 27th, 2018.**

We look forward to seeing you there. Slater is one mile E of Marietta, which is 5 miles North of Travelers Rest on Hwy 276.
